Scope and Content

The materials in FOIA 2017-1095-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material.

Freedom of Information Act Request 2017-1095-F is for records regarding climate change (and related keywords) in the Council of Economic Advisers office. The Council of Economic Advisers is comprised of three economists appointed by the President, with one economist serving as the chairperson. The CEA chairpersons under President Clinton were Laura Tyson (1993-1995), Joseph Stiglitz (1995-1997), Janet Yellen (1997-1999), and Martin Baily (1999-2001). Records responsive to this FOIA request were also found in the files of Michele Jolin, who served as Chief of Staff of the CEA under Joseph Stiglitz and Janet Yellen; as well as Jeffrey Frankel, who served as a member of the CEA beginning in 1996 and then as Chief Economist from 1997-1999.

The large number of records responsive to this request cover a wide variety of subtopics regarding climate change, including emissions and emissions trading, joint implementation, greenhouse gases,

sustainability, carbon sinks, clean development mechanisms, and international climate change negotiations such as the Kyoto Protocol, Less or Least Developed Country (LDCs) considerations, and the Intergovernmental Panel on Climate Change. There are also a considerable number of records that were compiled & produced in response to congressional inquiries, with associated testimonies before Congress.

A substantial amount of the records consist of economic models regarding climate change, as well as their corresponding analyses and peer reviews. There are a significant number of pages of handwritten notes and meeting notes, as well as memos, letters, press, briefing books, background material, talking points, drafts, publications, charts, meeting agendas and summaries, and reports.

Staff and Office files were maintained at the folder level by staff members within their individual offices and document all levels of administration activity.
