1. SUMMARY: THE WARRINGTON IRA BOMBING IN ENGLAND MAY
PUSH THE GOI INTO PROPOSING LONG-NEEDED AMENDMENTS TO
IRELAND'S EXTRADITION LAW WHICH WOULD FURTHER LIMIT THE
USE OF THE POLITICAL EXCEPTION DEFENSE BY IRA SUSPECTS
WANTED IN THE UK, NORTHERN IRELAND, AND OTHER
JURISDICTIONS, INCLUDING THE U.S. THE PARLIAMENTARY
OPPOSITION HAS SEIZED UPON THE ISSUE TO DEMONSTRATE THE
GOVERNMENT'S AMBIVALENCE ON THE ISSUE. END SUMMARY.
2. THE DEATHS OF TWO CHILDREN IN THE IRA BOMBING AT
WARRINGTON, ENGLAND, AS PREVIOUSLY REPORTED, HAVE
PROVOKED AN UNPRECEDENTED PUBLIC OUTCRY IN IRELAND
AGAINST THE TERRORIST VIOLENCE OF THE IRA AND, TO A
LESSER EXTENT, THE LOYALIST PARAMILITARIES IN THE
NORTH. IT HAS ALSO SPURRED OPPOSITION POLITICIANS IN
IRELAND TO URGE THAT IRISH EXTRADITION PROCEDURES BE
RATIONALIZED AND "LOOPHOLES" IN IRISH EXTRADITION LAW BE
CLOSED.
3. SPOKESPERSONS FOR FINE GAEL, THE PROGRESSIVE
DEMOCRATS AND THE DEMOCRATIC LEFT SAID RECENTLY THAT A
PRIVATE MEMBERS BILL WOULD BE INTRODUCED TO PUT PRESSURE
ON THE GOVERNMENT TO AMEND EXISTING EXTRADITION LAW BY
PROHIBITING THE USE OF THE POLITICAL OFFENSE EXCEPTION
FROM ALL TERRORIST CRIMES. UNDER THE 1987 EXTRADITION
ACT (WHICH IMPLEMENTED THE EUROPEAN CONVENTION IN
IRELAND) AND SUBSEQUENT SUPREME COURT RULINGS IN 1990,
THE POLITICAL OFFENSE EXCEPTION MAY BE INVOKED IN CASES
OF POSSESSION OF FIREARMS AND EXPLOSIVES, AND MURDER
WHEN OTHER THAN AUTOMATIC WEAPONS ARE USED.
4. THE WARRINGTON ATROCITY CLEARLY PUTS PRESSURE ON THE
RULING FIANNA FAIL/LABOR COALITION GOVERNMENT TO TAKE

ACTION ON EXTRADITION ISSUES AND JUSTICE MINISTER GEOGHEGAN-QUINN SAID ON APRIL 2 THAT THE GOVERNMENT WOULD BRING FORTH PROPOSALS TO AMEND THE 1987 ACT, "AS A MATTER OF URGENCY." FINE GAEL FOREIGN POLICY SPOKESPERSON NORA OWEN, HOWEVER, TOLD THE CONGEN AT AN EMBASSY LUNCHEON ON APRIL 2 THAT SHE EXPECTED LITTLE MOVEMENT. SHE POINTED OUT THAT THE ISSUE HAS BEEN PENDING FOR THE PAST THREE YEARS WITH NO ACTION BY THE GOVERNMENT. FIANNA FAIL GOVERNMENTS, IN THE PAST, HAVE BEEN SOMEWHAT RETICENT ABOUT EXTRADITING FUGITIVES TO THE U.K. OR NORTHERN IRELAND FOR CRIMES COMMITTED IN THE NORTH (THERE HAS BEEN MORE WILLINGNESS TO EXTRADITE FUGITIVE IRA MEMBERS FOR CRIMES COMMITTED ON THE BRITISH MAINLAND). FIANNA FAIL GOVERNMENTS HAVE PREFERRED TO RELY ON THE EXTRA-JURISDICTIONAL PROVISIONS OF THE CRIMINAL LAW ACT WHICH ALLOWS TRIAL AND INCARCERATION IN THE SOUTH FOR CRIMES COMMITTED IN THE NORTH.

5. OUR OWN CONTACTS WITH OFFICIALS IN THE IRISH JUSTICE SYSTEM ALSO REFLECT A CONCERN THAT THE SUPREME COURT HERE POSES THE GREATEST OBSTACLE TO EXTRADITIONS IN CASES INVOLVING THE CONFLICT IN THE NORTH. THE 1990 RULINGS CERTAINLY SET BACK THE EXTRADITION PROCESS IN IRA CASES, ALTHOUGH THERE HAVE BEEN SEVERAL CHANGES ON THE COURT SINCE THEN AND IT IS UNCLEAR HOW THE NEW JUSTICES WILL RULE ON THESE ISSUES. AMENDMENT OF THE EXTRADITION STATUTES WOULD ALSO IMPROVE PROSPECTS AT THE HIGH COURT AND SUPREME COURT LEVELS FOR EXTRADITION OF IRA AND OTHER TERRORIST SUSPECTS UNDER THE U.S.-IRELAND TREATY ON EXTRADITION.
