1. THE CATHOLIC PRIMATE OF IRELAND, CARDINAL CAHAL DALY, HAS ISSUED A STATEMENT IN WHICH HE DESCRIBED SINN FEINS NEGATIVE RESPONSE TO THE DOWNING STREET DECLARATION AS A "TRAGEDY FOR REPUBLICANS." HE WARNED REPUBLICANS THAT THEIR DECISION MEANT THAT THE PROCESS OF SHAPING "A NEW AND JUST AND BALANCED POLITICAL FUTURE FOR IRELAND" WOULD HAVE TO CONTINUE WITHOUT THEM. HE REMINDED SINN FEIN THAT THEIR "POLITICAL AIMS AND OBJECTIVES ARE RECOGNIZED BY BOTH THE IRISH AND BRITISH GOVERNMENTS", BUT THAT THOSE AIMS HAD TO BE PURSUED BY "PEACEFUL POLITICAL MEANS." WHILE REPUBLICANS CONTINUED TO SUPPORT THE IRAS VIOLENT CAMPAIGN, THEY WOULD BE EXCLUDED FROM THE POLITICAL PROCESS.
