Scope and Content

The materials in FOIA 2019-0666-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material.

FOIA 2016-0666-F is a request for photographs pertaining to Hillary Rodham Clinton's trip to South Asia from March 25, 1995 through April 10, 1995 (There were no responsive images for the dates April 6 through 10, 1995). First Lady Hillary Rodham Clinton traveled with Chelsea Clinton, Staff specifically, Lissa Muscatine, Lisa Caputo, Melanne Verveer, Capricia Marshall and others, to Egypt, Pakistan, India, Nepal, Bangladesh, Sri Lanka and Saudi Arabia.

This request contains photographs from the White House Photograph Office. The photographic events are included below:

March 25, 1995: Hillary Rodham Clinton and Chelsea Clinton arrive at Cairo Airport in Cairo, Egypt

March 25, 1995: Hillary Rodham Clinton and Chelsea Clinton tour the Pyramids and the Sphinx in Cairo. They are accompanied by Capricia Marshall, Lisa Caputo, Melanne Verveer and Kelly Craighead.

March 25, 1995: Hillary Rodham Clinton and Chelsea Clinton greet people before their departure from Cairo Airport

March 26, 1995: Hillary Rodham Clinton and Chelsea Clinton visit the Faisal Mosque in Islamabad, Pakistan

March 26, 1995: Hillary Rodham Clinton meets with Prime Minister Benazir Bhutto and others at the Prime Minister's residence in Islamabad. Chelsea Clinton joins the First Lady and Prime Minister Bhutto for a walk on the residence grounds.

March 27, 1995: Hillary Rodham Clinton and Chelsea Clinton arrive at the airport in Lahore, Pakistan

March 27, 1995: Hillary Rodham Clinton and Chelsea Clinton visit Lums University of Management Studies in Lahore. Hillary Rodham Clinton participates in a panel discussion with seminar students and addresses students at the university.

March 27, 1995: Hillary Rodham Clinton and Chelsea Clinton tour the Burki Village in Lahore. They visit the Women's Health Care Clinic, High School and the home of Burkat Ali in Burki Village.

March 27, 1995: Hillary Rodham Clinton, Chelsea Clinton, Prime Minister Bhutto and others attend a dinner hosted by Governor Chaudhry Altaf Hussain at Lahore Fort. Hillary Rodham Clinton, Chelsea Clinton and Prime Minister Bhutto visit vendors and artisans at the Fort.

March 27, 1995: Hillary Rodham Clinton and Chelsea Clinton greet guest house personnel in Lahore

March 27, 1995: Hillary Rodham Clinton visits with Prime Minister Bhutto and Ambassador and Mrs. John Monjo at Lahore Airport prior to departure. Hillary Rodham Clinton and Chelsea talk with staff during their flight.

March 27, 1995: Hillary Rodham Clinton and Chelsea Clinton visit the Islamabad College for Girls. They attend a panel discussion with Post-Graduate students. Chelsea Clinton enjoys a soda with students.

March 27, 1995: Hillary Rodham and Ambassador John Monjo address U.S. Embassy personnel and their families at the Ambassador's residence in Islamabad

March 27, 1995: Hillary Rodham Clinton and Chelsea Clinton greet people on their departure from Islamabad

March 28, 1995: Hillary Rodham Clinton Chelsea Clinton arrive at Palam Technical Airport in New Dehli, India

March 28, 1995: Hillary Rodham Clinton and Chelsea Clinton visit Prayas School Project and talk with students at the Indian Institute of Technology campus in New Dehli

March 29, 1995: Hillary Rodham Clinton and Chelsea Clinton visit the National Crafts Museum in New Dehli and watch artisans work and dancers in traditional costumes perform

March 31, 1995: Hillary Rodham and Chelsea Clinton arrive at Katmandu, Nepal. They are met by Ambassador Sandra Vogelgesand, Queen Aishwarya and others.

System of Arrangement
