Scope and Content

The materials in FOIA 2020-0424-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material.

President Clinton signs the budget bill in his Treaty Room Office on September 30, 1996. President Clinton talks with Vice President Gore, Leon Panetta, Tony Lake and John Hillely in the Treaty Room Office.

Additional photos on the responsive photo contact sheets include President Clinton conferring with Dennis Ross, Tony Lake, Leon Panetta and others in the Treaty Room Office, President Clinton greeting and meeting with King Hussein in the Diplomatic Reception Room and the Yellow Oval Room and Photos of Tony Lake and Doug Sosnik in a West Wing office. All of these events took place on September 30, 1996.

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series— Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
