Scope and Content

The materials in FOIA 2020-0014-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material.

This FOIA request contains information related to Bradley Byrne. The responsive records are from the WHORM Alpha File and the WHORM Subject File. This FOIA case contains letters and a resume recommending Byrne for the position of U.S. Attorney for the Southern District of Alabama. In addition, there is a letter written by Byrne to President Clinton dated March 15, 1994 in which he withdraws from consideration for that position.

System of Arrangement

Records that were responsive to this FOIA request were found in these collection areas-Clinton Presidential Records: White House Office of Records Management (WHORM) Alpha Files and Clinton Presidential Records: WHORM Subject Files.

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Alpha File was compiled by the

White House Office Records Management from 1993 - 1996 and is a series of documents arranged by name of persons, organizations, or events. The WHORM Subject File was compiled by the White House Office of Records Management and is a series of categories designated by a letter/number combination.

WHORM files are processed at the document level.
