Scope and Content

FOIA 2016-0100-F (Segment 11) is a request for all Clinton Administration White House photographs taken from December 1, 1999 through January 31, 2000.

The photographs processed in this segment were created from January 9, 2000 through January 18, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, press briefings, interviews, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, White House Staff and others for the time period processed.

Photographs from January 9, 2000 are as follows:

Secretary of State Madeleine Albright has lunch with Prime Minister Ehud Barak in Hillsboro, Virginia.

Photographs from January 10, 2000 are as follows:

President William Jefferson Clinton participates in a budget meeting with Larry Summers, Stuart Eizenstat, Martin Baily, Gene Sperling, Jack Lew, Chris Jennings, Sylvia Mathews, Bruce Reed, John Podesta, Steve Ricchetti, Chuck Brain, Joel Johnson, Karen Tramontano, and Maria Echaveste, among others.

President William Jefferson Clinton delivers a statement on Normal Trade Relation Status for China prior to departure for Annapolis, Maryland. Present include Bill Daley, John Podesta, and Steve Ricchetti. The President and First Lady Hillary Rodham Clinton attend the memorial service for Admiral Elmo Russell Zumwalt in Annapolis, Maryland.

President William Jefferson Clinton departs the White House en route to the Grand Canyon. The President arrives at the Grand Canyon National Airport. The President shops in the El Tovar hotel's store in Grand Canyon, Arizona.

Photographs from January 11, 2000 are as follows:

President William Jefferson Clinton greets El Tovar hotel personnel. The President departs for the Grand Canyon via Marine One. The President walks the Tuweep Valley. The President signs four proclamations including Proclamation 7263 (the establishment of the Agua Fria National Monument), Proclamation 7264 (the establishment of the California Coastal National Monument), Proclamation 7265 (the establishment of the Grand Canyon-Parashant National Monument), and Proclamation 7266 (the Boundary Enlargement of the Pinnacles National Monument). Present include Bruce Babbitt, Representative Sam Farr, Alan O'Neill, and Roger Taylor, among others.

President William Jefferson Clinton arrives at Houston Ellington Field in Houston, Texas.

President William Jefferson Clinton participates in a briefing at the Doubletree Hotel. Later the President proceeds to a reception for Sheila Jackson Lee and Mayor Lee P. Brown.

President William Jefferson Clinton departs Houston, Texas en route Andrews Air Force Base.

Photographs from January 12, 2000 are as follows:

President William Jefferson Clinton speaks on the telephone with Prime Minister Ehud Barak of Israel.

President William Jefferson Clinton meets with different individuals in the Oval Office, including Ambassador to Brazil Anthony Harrington, Abe Pollin, and Miles Lerman.

President William Jefferson Clinton is briefed on Northern Ireland prior to meeting with Gerry Adams. Present include Jim Steinberg and Sandy Berger. The President meets with Sinn Fein leader Gerry Adams. Present include Madeleine Albright.

President William Jefferson Clinton is briefed regarding the New Opportunity Agenda speech. Present include Gene Sperling, Jeff Shesol, Sidney Blumenthal, Bruce Reed, Loretta Ucelli, and Linda Moore,

among others. The President departs for George Washington University, where he delivers his New Opportunity Agenda speech to the Democratic Leadership Council.

President William Jefferson Clinton and Dorothy Rodham depart for White Plains, New York. The President and Mrs. Rodham arrive at Westchester County Airport.

Photographs from January 13, 2000 are as follows:

President William Jefferson Clinton participates in a briefing with Gene Sperling at the Sheraton Towers Hotel. The President proceeds to an interview with Lisa Lacks for NBC Sports

President William Jefferson Clinton participates in the unveiling of the Small Business Development Center at Boricua College in New York City. Present include Representative Nydia Velazquez, Aida Alvarez, and Jim King, among others.

President William Jefferson Clinton addresses the Wall Street project conference luncheon at the Sheraton Towers Hotel. Present include Reverend Jesse Jackson, Mayor Willie Brown, Sanford Weill, Robert Knowling, Berry Gordy, Douglas Ivester, and Ivan Seidenberg, among others.

President William Jefferson Clinton participates in an interview with Ron Insana for the CNBC program "Business Center" at the New York Stock Exchange. The President proceeds to deliver remarks at the Wall Street Project Reception. Present include Reverend Jesse Jackson and Richard Grasso.

Photographs from January 14, 2000 are as follows:

President William Jefferson Clinton, First Lady Hillary Rodham Clinton, and Dorothy Rodham return to the White House from their trip to New York.

President William Jefferson Clinton participates in a briefing with Chris Jennings, Joe Lockhart, and Gene Sperling in the Oval Office. The President proceeds to the Roosevelt Room to deliver remarks on airline safety. Present include Jane Garvey, Mort Downey, Don Carty, Leo Mullen, Dennis Dolan, Richard Lavoy, and Mark DeAngelis, among others.

Photographs from January 15, 2000 are as follows:

President William Jefferson Clinton delivers his weekly radio address in the Oval Office. The President greets guests in attendance including Charlotte Filmore, one hundred years old, whom had worked at the White House.

President William Jefferson Clinton departs from the Foundry United Methodist Church.

Photographs from January 17, 2000 are as follows:

President William Jefferson Clinton participates in a briefing in the Oval Office. Present include Madeleine Albright, Samuel “Sandy” Berger, Dennis Ross, Martin Indyk, Rob Malley, Bruce Riedel, and John Podesta.

President William Jefferson Clinton attends a Martin Luther King Day event at the Boys & Girls Club of Greater Washington. Present includes Mayor Anthony Williams. The President assists students and members of Americorps at the center with projects.

First Lady Hillary Rodham Clinton greets guests at the White House including Kim Henry.

System of Arrangement

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration.
