Scope and Content

FOIA 2008-0666-F (Segment 40) is a request for all Clinton Administration White House photographs taken from July 1, 2000 through December 31, 2000.

The photographs processed in this segment were created from December 17, 2000 through December 20, 2000. The segment contains photographs pertaining to: arrivals, departures, meetings, ceremonies, photo-ops, etc., involving President Clinton, Hillary Rodham Clinton, Chelsea Clinton, staff and others for the time period processed. Of particular focus is holiday festivities in Washington, DC, including parties and similar staff events at the White House.

Photographs from December 17, 2000 are as follows:

President William Jefferson Clinton and First Lady Hillary Rodham Clinton greet guests at a Christmas holiday party.

Photographs from December 18, 2000 are as follows:

President William Jefferson Clinton greets Nancy Hernreich in the Oval Office. The President proceeds to the West Lobby where he speaks with P.J. Crowley. Later the President proceeds back into the Oval Office and meets with Robert Barnett & Bruce Lindsey

President William Jefferson Clinton participates in an interview with Dan Rather at the White House.

President William Jefferson Clinton greets guests in the Oval Office including the Tatom family and Aaron Tonkin

President William Jefferson Clinton meets with President Jacques Chirac of France and President Romano Prodi of the European Commission at the White House. Present is Felix Rohatyn, United States Ambassador to France. President Clinton, President Chirac, and President Prodi participate in a European Council Summit Trans-Atlantic Dialogue meeting at the White House. Present include Madeleine Albright, Richard Holbrooke, Norman Mineta, Charleen Barshefsky, Richard Morningstar, and Gene Sperling, among others.

President William Jefferson Clinton meets with senior staff in the Cabinet Room regarding the transition to the Bush administration (President-elect George W. Bush visits the following day). Present include John Podesta, Maria Echaveste, Karen Tramontano, Gene Sperling, Bruce Reed, Steve Ricchetti, and Jake Siewert.

President William Jefferson Clinton arrives in New York City. The President greets individuals present at the Waldorf Astoria Hotel.

Photographs from December 19, 2000 are as follows:

President William Jefferson Clinton meets with senior staff in the Oval Office including Sandy Berger, Nancy Hernreich and Steve Ricchetti. The President later meets with Terry McAuliffe, Joe Andrew and Minyon Moore.

President William Jefferson Clinton greets various individuals and groups in the Oval Office, including publisher Michael Chzteyan & Set Momjian, the Enrico Fermi Award winners, the Malcolm Baldrige awardees, and Sheila Lawrence and her son. The President later meets with Bill Richardson.

President William Jefferson Clinton meets with Stephanie Streett Erbach and Laura Graham in the Oval Office.

President William Jefferson Clinton participates in a photo shoot with Simmie Knox. Present during the shoot include John Podesta, Betty Currie, Glen Maes, and Eugenie Bisulco.

President William Jefferson Clinton meets with President-elect George W. Bush at the White House. The press pool participates in a photo opportunity. Present include Helen Thomas, Frank Johnston, Ellen Olcott, and Doug Band, among others. President Clinton and President-elect Bush tour the White House. (These images were processed in FOIA case # 2017-0231-F and should be referenced for the material).

President William Jefferson Clinton speaks with Mara Rudman, Jake Siewert, John Podesta and Steve Ricchetti in the Map Room.

President William Jefferson Clinton and First Lady Hillary Rodham Clinton addresses the Presidential Interagency Council on Women ceremony in the East Room at the White House. Present are Donna Shalala and Madeleine Albright, among others.

President William Jefferson Clinton and First Lady Hillary Rodham Clinton participate in the annual Christmas Story Hour at the White House.

Photographs from December 20, 2000 are as follows:

President William Jefferson Clinton and First Lady Hillary Rodham Clinton greet Institute of Museum and Library Sciences (IMLS) award recipients.

President William Jefferson Clinton addresses a medical privacy event at the Department of Health and Human Services. Present include Donna Shalala and Janlori Goldman, among others.

First Lady Hillary Rodham Clinton is presented with an American Association of Museums (AAM) accreditation certificate from AAM President Ed Able.

First Lady Hillary Rodham Clinton participates in a Mothers Against Drunk Driving (MADD) event titled "Tie One on For Safety." Present is Rodney Slater, among others.

First Lady Hillary Rodham Clinton visits the National Children's Medical Center in Washington, DC.

President William Jefferson Clinton and First Lady Hillary Rodham Clinton present the National Medal of Arts & Humanities awards. National Medal of Arts honorees are Maya Angelou, Eddy Arnold, Mikhail Baryshnikov, Benny Carter, Chuck Close, Horton Foote, Lew Manilow, Kevin Klose, Claes Oldenburg, Itzhak Perlman, Hal Prince, and Barbara Streisand. National Medal of Humanities honorees are Robert Bellah, William Davis Campbell, Judy Chrichton, David Driskell, Ernest Gaines, Herman Guerrero, Quincy Jones, Barba Kingsolver, Edmund Morgan, Toni Morrison, and Virginia Driving Hawk Sneve. Following the event the President, First Lady, and Chelsea Clinton attend a dinner held in the South Lawn Pavilion. They greet guests present.
