Scope and Content

The materials in FOIA 2020-0095-F are a selective body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related material.

The Secretary of Defense from February of 1994 through January of 1997 was Dr. William Perry. His tenure as SECDEF coincided with the conclusion of the Bosnian War and the NATO led Implementation Force (IFOR) deployment to Bosnia-Herzegovina to enforce the peace agreed to at the Dayton Peace Accords.

Materials responsive to this FOIA request include routing memorandums regarding reports to the President from the Secretary, correspondence from various Senators about the conflict in Bosnia, foreign travel request paperwork from the Secretary of Defense's Office, scheduling forms concerning briefings given by the Chairmen of the Joint Chiefs of Staff, commendation letters from the President to the Secretary of Defense, and memoranda concerning emergency funding and the call-up of the military reserves to active duty.
