SUBJECT: SHOTS FIRED DURING HUNGER STRIKE COMMEMORATION MARCH
1. SHOTS WERE FIRED ACROSS THE WEST BELFAST "PEACE LINE" DURING A SINN FEIN MARCH ON MAY 15 TO COMMEMORATE THE 1981 IRA HUNGER STRIKE. NO-ONE WAS INJURED. THE CROWD OF ABOUT 250 SCATTERED BRIEFLY, BUT THE MARCH TO BELFAST CITY HALL CONTINUED. SINN FEIN SPOKESMEN CRITICIZED A POLICE STATEMENT WHICH INDICATED THAT THE RUC BELIEVED THE SHOTS HAD BEEN FIRED INTO THE AIR, NOT AT THE MARCHERS. MAIRTIN O MUILLEOIR, A SINN FEIN BELFAST CITY COUNCILLOR, WAS SCATHING IN HIS CRITICISM OF THE POLICE. HE SAID "DOES THE ASSISTANT CHIEF CONSTABLE STILL WANT US TO BELIEVE THAT THE UDA SENT OUT TWO MEN WITH RIFLES TO THE PEACELINE TO FIRE SHOTS IN THE AIR?"
2. THE MARCH ENDED AT BELFAST CITY HALL WHERE THERE WAS A SHORT RALLY. THE MARCHERS THEN DISPERSED PEACEFULLY. A SIMILIAR DEMONSTRATION PLANNED FOR LAST WEEK HAD BEEN BANNED FROM THE CITY CENTER BY THE RUC. THE DECISION TO LET THE MAY 15 MARCH GO AHEAD INFURIATED UNIONISTS. ULSTER UNIONIST COUNCILLOR NELSON MCCAUSLAND ACCUSED THE NORTHERN IRELAND OFFICE (NIO) OF "CAPITULATING TO THE PROVOS." DUP LEADER IAN PAISLEY CLAIMED THAT THE NIO HAD ORDERED THE RUC TO ALLOW THE MARCH TO GO AHEAD AFTER REPRESENTATIONS BY THE IRISH GOVERNMENT.

1. NORTHERN IRELAND POLITICIANS HAVE REACTED SWIFTLY TO REMARKS MADE BY SINN FEIN PRESIDENT GERRY ADAMS IN A BBC INTERVIEW ON MAY 26, IN WHICH HE SAID THAT IT WAS UNLIKELY THAT SINN FEIN WOULD REQUIRE FURTHER CLARIFICATION OF THE DOWNING STREET DECLARATION.
2. SDLP DEPUTY LEADER, SEAMUS MALLON, SAID THAT ADAMS FACED A DOUBLE TASK IF HE WAS SEEKING CREDIBILITY FOR HIS STATEMENT. FIRST, ADAMS WOULD HAVE TO BE CONSISTENT, SINCE SINN FEIN HAD "WRIGGLED ON EVERY HOOK AND USED EVERY CONTRIVANCE TO TRY AND PROLONG THIS PROCESS." SECOND, MALLON SAID, HE (ADAMS) WOULD HAVE TO POSITIVELY TELL THE PEOPLE OF NORTHERN IRELAND THAT THE IRA WOULD ABANDON ITS CAMPAIGN OF VIOLENCE AND ENTER THE POLITICAL PROCESS. MALLON SAID "WHEN I HEAR THAT, THEN ILL BECOME EXCITED AND THEN ILL BECOME VERY OPTIMISTIC - BUT UNTIL I DO, ILL RESERVE JUDGEMENT."
3. ULSTER UNIONIST MP DAVID TRIMBLE, REFERRING TO A STATEMENT BY ADAMS IN THE INTERVIEW THAT THE IRISH GOVERNMENT HAD HELPED PUSH JOHN MAJOR INTO "A SIGNIFICANT U-TURN", SAID THERE WOULD BE A NEED FOR "STRAIGHT TALKING TO ASK MR. REYNOLDS WHOSE SIDE HE IS ON." TRIMBLE CONTINUED "HE (REYNOLDS) ASSISTED THE IRA IN THEIR PROCESS, WHICH IS NOT A PROCESS TOWARDS PEACE, BUT DELIVERING TO MR. ADAMS THE VICTORY THAT HE SEEKS."
4. DEMOCRATIC UNIONIST PARTY DEPUTY LEADER PETER ROBINSON SAID THAT THE SINN FEIN COMMENT WAS A "CYNICAL PLOY" AND SUGGESTED THAT ADAMS WAS ENGAGED TO TRYING TO RAISE THE PROFILE OF HIS PARTY IN THE RUN UP TO THE EUROPEAN ELECTIONS. ROBINSON SAID THAT THE IRA HAD ALREADY GIVEN ITS RESPONSE WHEN IT KILLED NIGEL SMYTH, THE YOUNG SECURITY GUARD WHO WAS SHOT IN BELFAST CITY CENTER ON MAY 23.
