SUBJECT: NORTHEVN IRELAND POLICE AUTHORITY PUBLISHES REPORT
ON FUTURE ROLE OF POLICING.

1. SUMMARY: ON JANUARY 4, 1995, THE POLICE

AUTHORITY FOR NORTHERN IRELAND, UNDER ITS THEN
CHAIRMAN DAVID COOK, ANNOUNCED A COMPREHENSIVE
CONSULTATION OF COMMUNITY OPINION ON POLICING
AND THE POLICE. THE CONSULTATION WAS TO BE
CONDUCTED IN PURSUIT OF THE AUTHORITY'S STATUTORY
DUTY TO MAKE ARRANGEMENTS FOR OBTAINING THE
GENERAL PUBLIC'S VIEW ON POLICING. THE REPORT IS
NOW COMPLETE AND HAS BEEN FORMALLY PRKSENTED TO
THE CHIEF CONSTABLE AND THE SECRETARY OF STATE
FOR NORTHERN IRELAND. END SUMMARY.

2. CONCERNS ABOUT CRIME:

BASED ON THE REPORT'S FINDINGS, THE POLICE
AUTHORITY CONCLUDED THAT THE PRINCIPAL CONCERN
WAS ABOUT CRIME. SPECIFICALLY, COMMUNITY
ANXIETIES ABOUT DRUG ABUSE, FOOT PATROLS AND
COMMUNITY SAFETY. THE AUTHORITY SUGGESTED THE
CHIEF CONSTABLE ENGAGE THE COMMUNITY MORE IN
TACKLING CRIME AND ENCOURAGE THE SECRETARY OF

STATE TO INTRODUCE A POLICE OBJECTIVE SETTING PROCESS AS EXISTS IN ENGLAND AND WALES WHERE THE COMMUNITIES THERE ARE ACTIVELY INVOLVED IN DETERMINING POLICE PRIORITIES. THE REPORT CONCLUDED THERE WAS A BROAD MEASURE OF SUPPORT FOR THE RUC AND A HIGH LEVEL OF SATISFACTION WITH THE WAY THEY DEAL WITH THE PUBLIC. WHAT PEOPLE WANTED WAS A POLICE SERVICE WHICH WAS FAIR, IMPARTIAL AND EFFECTIVE.

3. NAME, UNIFORM AND BADGE:

THE REPORT RECOGNIZED THAT THESE WERE CONTENTIOUS ISSUES AND RECOMMENDED THAT, WHILE THE NAME SHOULD BE LEFT UNCHANGED, THE SUFFIX "NORTHERN IRELAND'S POLICE SERVICE" SHOULD BE ADDED IN PRINTED REFERENCE TO THE FORCE. THE UNIFORM AND INSIGNIA OF THE HARP AND CROWN SHOULD ALSO BE LEFT UNCHANGED.

4. UNION FLAG:

IN GENERAL, PUBLIC OPINION FAVORED THE UNION FLAG BEING FLOWN AT POLICE STATIONS. HOWEVER CATHOLICS WOULD PREFER IT TO BE FLOWN AT GOVERNMENT BUILDINGS ONLY. FURTHER CONSULTATION ON THE ISSUE OF THE FLAG IS TO BE CARRIED OUT.

5. OATH OF OFFICE:

THE REPORT NOTED THAT THE OATH SWORN BY RUC OFFICERS IS NOT AN "OATH OF ALLEGIANCE." IT IS MORE PROPERLY AN "OATH OF OFFICE." IT PROPOSES TO CONSULT WITH THE SECRETARY OF STATE WITH A VIEW TO REVISING THE WORDING.

6. RELIGIOUS COMPOSITION:

SOME OF THOSE WHO WROTE SUBMISSIONS AGREED THAT THE FORCE SHOULD HAVE A HIGHER PROPORTION OF CATHOLICS THAN AT PRESENT. PUBLIC OPINION ALSO SHOWED WIDESPREAD SUPPORT FOR MORE FEMALE OFFICERS. THE REPORT RECOMMENDED THE SETTING UP OF A WORKING PARTY TO CONSIDER HOW BEST TO TACKLE THESE ISSUES.

7. COMMUNITY POLICING:

ON THE ISSUE OF COMMUNITY POLICING, THE REPORT BELIEVED THAT COMMUNITY POLICING, INTER-AGENCY CO-OPERATION AND THE DEVELOPMENT OF COMMUNITY PARTNERSHIPS ALL HAVE AN IMPORTANT PART TO PLAY IN BUILDING POLICE EFFECTIVENESS AND DEVELOPING CLOSER RELATIONSHIPS BETWEEN THE PUBLIC AND THE POLICE. THE AUTHORITY SAID IT WOULD CONTINUE ITS RESEARCH ON THESE ISSUES AND PASS ON THEIR CONCLUSIONS TO THE CHIEF CONSTABLE. THE REPORT

COMPLAINTS -- THE AUTHORITY SAID IT WOULD CO-

RELATIONSHIP WITH THE IRISH POLICE SERVICE -- THE AUTHORITY NOTED THE HIGH LEVEL OF PUBLIC SUPPORT FOR THE CONTINUATION OF CO-OPERATION BETWEEN THE RUC AND THE GARDA SIOCHANA.

EMERGENCY LEGISLATION AND ARMING THE POLICE -- THE POLICE AUTHORITY SAID IT LOOKED FORWARD TO THE DAY WHEN NO SUCH LEGISLATION WOULD BE REQUIRED. IT ALSO RECOGNIZED THAT THE DECISION AS TO WHETHER POLICE OFFICERS SHOULD BEAR ARMS WAS AN OPERATIONAL ONE AND WAS FOR THE CHIEF CONSTABLE TO DETERMINE.

9. FINDINGS AND RESULTS:

2,682 RESPONDENTS WERE INTERVIEWED IN THE SURVEY. THE RESULTS WERE AS FOLLOWS:

91 PER CENT WANTED TO SEE AN INCREASE IN ANTI-DRUGS POLICING.

84 PER CENT WHO WANTED MORE ACTION IN THE AREA OF CRIME PREVENTION.

77 PER CENT SAID THE POLICE WERE POLITE AND HELPFUL.

66 PER CENT SAID THE POLICE DEALT FAIRLY WITH EVERYONE.

OVERALL, THOSE WANTING THE NAME OF THE RUC TO REMAIN UNCHANGED OUTNUMBERED THOSE SEEKING CHANGE BY 3 TO 1. HOWEVER, THE PROTESTANT COMMUNITY WAS FIRMLY OPPOSED TO ANY CHANGE WHILE THE CATHOLIC COMMUNITY WAS SLIGHTLY IN FAVOR (49 PER CENT IN FAVOR, AND 45 OPPOSED). 54 PER CENT OF RESPONDENTS WERE IN FAVOR OF NO CHANGE TO THE RUC, 29 PER CENT SAID IT SHOULD BE REFORMED AND 14 PER CENT SAID IT SHOULD BE REPLACED WITH A NEW FORCE. LESS THAN 1 PER CENT WANTED THE FORCE DISBANDED.

92 PER CENT SAID THE FORCE SHOULD CONTINUE TO BE ARMED, AT XKO#TO SEE MORE FEMALE OFFICERS.

75 PER CENT THOUGHT POLICE TRAINING COULD BE IMPROVED AND 30 PER CENT THOUGHT THE POLICE
