985 photographs in color and black & white film processed from 35mm negatives and born-digital files and 6 video recordings in BetacamSP & Digital Betacam format totaling approximately 130 minutes (2 hours & 10 minutes) total run time.

Scope and Content

FOIA 2020-0378-F is a request for all photographs and video recordings of President William Jefferson Clinton meeting with members of the Saudi Arabian royal family, along with other Saudi Arabian related materials. The material consists primarily of the President participating in meetings at the White House. Present at these meetings and events include King Fahd bin Abdulaziz Al Saud (فهد بن عبد العزيز آل سعود), Prince Abdullah bin Abdulaziz Al Saud (عبدالله بن عبدالعزيز آل سعود), Foreign Minister Saud bin Faisal bin Abdulaziz Al Saud (سعود بن فيصل بن عبد العزيز آل سعود), Prince Al-Waleed bin Talal bin Abdulaziz al Saud (الوليد بن طلال بن عبدالعزيز آل سعود), and Prince Bandar bin Sultan. Administration staff present at the events include Vice President Al Gore, Tony Lake, Warren Christopher, Sandy Berger, Ron Brown, Federico Pena, Mack McLarty, Bruce Riedel, Dee Dee Myers, Mark Gearan, David Gergen, Dennis Ross, Robert Rubin, Martin Indyk, Leon Panetta, Nancy Hernreich

A selection of material was previously processed in other FOIA cases, of note including material relating to the President's trip to Saudi Arabia in 1994 that was previously processed in FOIA # 2016-0242-F.

System of Arrangement

Records that were responsive to this FOIA request were found in two collections and two series, Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein – Photographs Relating to the Clinton Administration, and Clinton Presidential Records: Video Recordings of the White House Television Office and the series therein – Video Recordings Relating to the Clinton Administration. Processing was done at the folder/contact sheet level for photographs and at the individual item level for video. While this method maintains folder/contact sheet integrity for photographs and tape run time integrity for video, it frequently results in the incidental processing of photographs and video that are not wholly responsive to the subject area.
