#### **Extent**

Approximately 115 photographs in color and black & white film processed from 35mm negatives.

#### **Access**

#### **Scope and Content**

FOIA 2019-0649-F is a request for photographs of First Lady Hillary Rodham Clinton on flights to Islamabad, Pakistan on March 25, 1995 and to New Delhi, India on March 31, 1995. In addition to the First Lady present on the flights include Chelsea Clinton, Capricia Marshall, Lisa Caputo, Kelly Craighead, and various press reporters traveling with the entourage.

#### **System of Arrangement**

Records that were responsive to this FOIA request were found in one collection area and one series—Clinton Presidential Records: Photographs of the White House Photograph Office and the series therein—Photographs Relating to the Clinton Administration. Processing is done at the Folder/Contact sheet level. While this method maintains folder/contact sheet integrity, it frequently results in the processing of photographs that are not wholly responsive to the subject area.
