Madeleine Albright held the position of U.S. Ambassador to the United Nations from the beginning of the Clinton Administration until 1997 when she succeeded Warren Christopher as Secretary of State.

Materials responsive to this FOIA request include routing memorandums regarding reports to the President, foreign travel request paperwork from the Ambassador Albright's Office, draft remarks for the use of Secretary of State Warren Christopher, notifications of Principals Committee Meetings regarding the Bosnian conflict, and memoranda concerning diplomatic contacts.
